AIC VOLLEYBALL BY LAWS 2019

RULES PERTAINING TO ALL TEAMS

Clause 1: GRADES AND AIC AGGREGATE

(a) Grades catered for, and count towards the AIC Aggregate shall be:

1st VI, 2nd VI, 3rd VI, 11A, 10A, 10B, 9A, 9B, 8A, 8B, 7A, 7B

(b) Additional grades maybe catered for subject to availability:

4th VI, 11B, 10C, 9C, 8C, 7C

Clause 2: AGGREGATE POINTS

The following teams only shall count towards the AIC Aggregate:

1st VI, 2nd VI, 3rd VI, 11A, 10A, 10B, 9A, 9B, 8A, 8B, 7A, 7B

Clause 3: COMPETITION POINTS

Win = 2 Loss = 0

The exception to this rule pertains to the First VI, refer to Rules Pertaining to First VI

Clause 4: SCORING SYSTEM

- a) With the exception of the 1st VI, all games are played in a best of 3 set format
- b) Games are played according to standard FIVB rules with the first two sets to 25 and the third, when required, to 15. In a third and deciding set, when a team reaches 8 points, teams are to change ends.
- c) Years 7, 8 and 9 games are to play all 3 sets. Years 10, 11 and Open DO NOT play dead sets.
- d) Rules regarding net touches will make reference to the FIVB Rules: Law 11.3 "Contact with the Net".

Rule 11.3.1: Contact with the net by a player between the antennae, during the action of playing the ball is a fault. The action of playing the ball includes (among others), take off, hit (or attempt) and landing.

Rule 11.3.2: Players may touch the posts, ropes or any other object outside the antennae, including the net itself, provided that it does not interfere with the play.

Rule 11.3.3: When the ball is driven into the net, causing it to touch an opponent, no fault is committed.

Clause 5: PLAYER RESTRICTIONS

a) Players may take part in only one game in one year level on any given fixture day. The only exception to this rule is where a player acts as a reserve for the 1st VI. These players may only enter the 1st VI game after the first set. There shall be no more than fourteen (14) players per school registered on the score card for the 1st VI match, these players are to be recorded on the score sheet prior to play.

Clause 6: MATCH TIMES

The following schedule shall apply where possible:

Clause 7: FORMAT OF MATCHES

a) WARM UP

Umpires will control the warm up. A total of ten (10) minutes only is permitted for warm up as set out below on the match court. At the conclusion of this ten minute period, teams will be asked to take the court in preparation for play.

10 Minute Warm up Protocol

Ball warm up 2 minutes
Coin Toss
Spiking from 4 3 minutes
Spiking from 2 3 minutes
Serving 1 minute
Coach 1 minute

b) LIBERO

- i. A Libero player is allowed in all grades and shall be determined at the beginning of each set.
- ii. A Libero player must wear a contrasting coloured shirt to his team.

c) SUBSTITUTIONS

i. Unlimited substitutions shall be permitted for all grades except the First VI and as per FIVB rules.

d) TIME OUTS

ii. Two time outs per set per team is permitted.

Clause 8: HEIGHT OF NETS

The height of the nets for all levels of the competition shall comply with current FIVB rules.

Clause 9: OFFICIALS

- a) Where possible, AIC qualified referees shall be used for 1st, 2nd, 11A and 10A matches. When not available, the home team shall supply an adult referee and umpire for the 1sts and 2nds matches. Senior students who have completed a recognised referee's course may referee and umpire Year 7, Year 8, Year 9 and Year 10 matches.
- b) The "Home College" shall provide second referees for all aggregate games.
- C) The home college is to provide scorekeepers for matches. The scorekeepers shall complete a scoresheet, which must be signed by the referee and both coaches/captains at the end of the match. The away team reserves the right to provide scorekeepers if so desired.
- d) The home college is to provide lines people for all matches. The away team reserves the right to provide lines people if so desired.
- e) The "Home" College shall provide a visible scoreboard and operator for each court.

Clause 10: BALLS

- a) The host college is to provide balls for matches and warm-up for all competing teams. Visiting colleges are not to take balls to match venues.
- b) For all AIC matches the MVA 200 ball must be used.

Clause 11: UNIFORM

It is compulsory for all aggregate teams to wear correctly numbered shirts.

Clause 12: MEDICAL

Adequate sports medicine staff and first aid facilities are to be available.

Clause 13: HOSPITALITY

Afternoon tea is to be provided for First players and coaches from each College after the match.

RULES PERTAINING TO FIRST VI MATCHES

Clause 1: FORMAT OF MATCHES

All matches shall be played to the best of five (5) sets.

Clause 2: COMPETITION POINTS

Winning team will receive 2 points

Each team will receive 1 point for every set won regardless of which team wins the game.

Clause 3: SCORING SYSTEM

- a) The match is won by the team that wins the majority of the five sets.
- b) The fifth deciding set is played under point rally. The first team to 15 with an advantage of two points (no maximum score limit) shall win the match. When a team reaches eight points, teams shall change ends.

Clause 4: SUBSTITUTIONS

Twelve (12) substitutions per set are permitted in First VI matches
